



PRINCIPLES OF ADULT LEARNING (PAL) TRAINING DEVELOPING LIST

To meet this requirement the trainer applicants must have completed coursework focused on the unique needs and characteristics of adults as learners or received training in Principles of Adult Learning (PAL) Training. The trainer applicant must document at least 6 hours of coursework or training in the following:

- Best Practices for Adult Education
- Instructional Design
- Facilitation
- Assessment for Adult Education

Resources for Principles of Adult Learning (PAL) Training

This 6 hour requirement may be met in a number of ways:

College Coursework Previously Taken

To document these clock hours of training in adult education or adult development, the applicant must submit a copy of the transcript showing satisfactory completion of the course or courses. Additionally, official course descriptions from the college catalog may be required.

Training of Trainers

Applicants may have attended training of trainers classes in face-to-face or online formats. These are classes that prepare a trainer to present a specified training curriculum or that include content on how to organize training sessions, develop a training business, etc. To document these clock hours, the trainer must submit a copy of the certificate that includes training organization information, trainer name, dates, and clock hours of training received.

Typically held in June, the institute is designed for those who provide professional development experiences for the early childhood workforce.
